Subject: 2.7 Production Statement: changing method of recording

ALA thanks BL for this proposal which demonstrates the scope of changes required to RDA 2.7 in order to change the basic instruction from transcribing to recording the production information. We generally support this proposal. Although BL has characterized this as a potential quick fix, we have identified broader implications and recommend some significant rewording if the JSC would like to proceed in making this change now.

Issues to be resolved

Self-describing vs. non-self-describing resources

As part of the discussion of 6JSC/ALA/Discussion/4, members of the JSC expressed interest in making a distinction between resources that were self-describing and those that were not, rather than making the distinction between published and unpublished resources. ALA continues to prefer transcribing production information from self-describing resources, although we observe that the changes BL proposes only allow for transcription of production information in a note.

Wording changes that impact more than just RDA 2.7

Because this proposal is characterized as a quick fix, ALA generally does not agree to wording changes that apply beyond RDA 2.7. This includes the proposed change from "on the source of information" to "in the source of information", and the rewording suggestions for multipart monographs (2.7.1.5.1) and serials (2.7.1.5.2). That being said, we support the proposed changes in 2.7.6.5, provided that the same changes are made in 2.8.6.5, 2.9.6.5, and 2.10.6.5.

References RDA 1.8, Numbers Expressed as Numerals or as Words (2.7.1.4, 2.17.6.3) ALA believes that the applicable references to 1.8 need to be retained in 2.7. These instructions apply to recorded information.

Determining the correct form of place name to record (2.7.2.3, 2.7.2.5)

ALA is uncertain about the impact of the changes in recording the place of production (2.7.2.3). Is it reasonable to expect the cataloger to record "Praha" if the resource says "V Praze"? Since these instructions are about recording information, and not recording relationships, we wonder if this takes the concept of "recording" too far. In our proposed text below, we have not made this change.

On the other hand, we believe the instructions in 2.7.2.5 are too explicit in how to identify the correct form of the place name if it appears in more than one language or script. We think that this general situation is addressed by RDA 1.4. Thus, ALA recommends simplifying this phrasing to just "the language or script preferred by the agency preparing the description".

Treatment of fictitious information (2.7.2.3, 2.7.4.3, 2.7.6.3)

The proposal suggests a significant change in practice for capturing information about fictitious places of production and fictitious producers: recording the correct information and making a note about the fictitious statement. However, the equivalent change for date of production was not proposed. ALA recommends the same approach for all fictitious information. Thus, we support the BL approach for 2.7.2.3 and 2.7.4.3, but we recommend extending this practice to 2.7.6.3 as well. To reflect current RDA usage, we recommend using the term "real name" for places and producers, but "actual date" for date of production.

Guidance for "more than one" place of production (2.7.2.4) or producer (2.7.4.5)

The proposal offers very flexible language in 2.7.2.4 (More Than One Place of Production) and 2.7.4.5 (More Than One Producer), which includes a reference to RDA 0.6.4. ALA disagrees with this approach, because it does not provide sufficient guidance to the cataloger about how to make the decision about how many places or producers to record.

What does "not identified" mean in the context of recording information? (2.7.2.6, 2.7.4.7, 2.7.6.6)

ALA recommends using the term "uncertain" in the instruction titles relating to probable or unknown information for place of production, producer, and date of production. With the source of information changing to "any source", the current phrase ("not identified") is too limiting.

Instructions for correct placement of the question mark (Probable Place of Production, 2.7.2.6.1)

ALA recommends simplifying this instruction; in all cases, the recorded place name is followed by a question mark.

Inclusion of parallel information for place of production (2.7.3) and producer (2.7.5) In 6JSC/ALA/Discussion/4, ALA raised the question of the relevance of parallel information for place of production and producer. Two of the constituencies responded stating that this information is still applicable to unpublished resources. ALA believes that changing from transcription to recording in 2.7 does not necessarily impact these instructions, and we do not agree to remove them. We note that if these instructions are retained, they still need to be reworked to match the changes proposed for the rest of 2.7.

Role of the Statement of Function (RDA 2.7.4.4)

As currently phrased, the Statement of Function is included in a description if it appears in the resource. While ALA agrees that this instruction needs to be modified if 2.7 changes from transcribe to record, we believe that this particular constraint should still apply. Otherwise, recording the Statement of Function could be applicable to all unpublished resources.

Instruction text that only refers to making a note (2.7.6.4)

ALA believes that references in 2.7 to 2.17 are more appropriate as alternatives or as secondary paragraphs, rather than as the primary or only instruction.

Accommodating notes on sources of information for production statements (2.17.6)

ALA agrees with the proposed final paragraph in 2.7.1.2, Sources of Information. However, supporting changes need to be made to 2.17.6 to allow for recording the source of production information in a note.

Optional transcription of production information (2.17.6.3)

ALA is not convinced that the optional addition for transcribing production information falls into the category of details relating to a production statement. Instead, we have proposed an Optional Addition for 2.7.1.4.

Defining "inscription" (Glossary)

While ALA agrees to add a definition of "inscription" to the Glossary, we believe that the definition should focus on the act of inscribing, rather than the product. In this context, "inscription" refers to the activity.

Optional Addition

If considered important for identification or access, make a note (see 2.17.6) transcribing the place of production, producer, and/or date of production as they appear on the resource. Apply the general guidelines on transcription for words that are not numbers (see 1.7). Apply the general guidelines on numbers expressed as numerals or as words (see 1.8).

2.7.1.5 Recording Changes in Production Statements

2.7.1.5.1 Multipart Monographs

Make a note (see 2.17.6.54.1) if:

the place of production changes on a subsequent part of a multipart monograph and

the change is considered important for identification or access.

If the change is only in the presentation of the place name, make a note if the change is considered important for identification.

Alternative

If the changes have been numerous, make a general note (see 2.17.6.54.1).

Make a note (see 2.17.6.54.1) if:

a producer's name changes or a different producer is named on a subsequent part of a multipart monograph

and

the change is considered important for identification or access.

If the change is only in the presentation of the name, make a note if the change is considered important for identification.

Alternative

If the changes have been numerous, make a general note (see 2.17.6.54.1).

2.7.1.5.2 Serials

Make a note (see 2.17.6.54.2) if:

the place of production changes on a later issue or part of a serial

and

the change is considered important for identification or access.

If the change is only in the presentation of the place name, make a note if the change is considered important for identification.

Alternative

If the changes have been numerous, make a general note (see 2.17.6.54.2).

Make a note (see 2.17.6.54.2) if:

a producer's name changes or a different producer is named on a later issue or part of a serial

and

the change is considered important for identification or access.

If the change is only in the presentation of the name, make a note if the change is considered important for identification.

Alternative

If the changes have been numerous, make a general note (see 2.17.6.54.2).

2.7.1.5.3 Integrating Resources

Change the place of production to reflect the current iteration of an integrating resource. Make a note on the earlier place if considered important for identification or access (see 2.17.6.54.3).

Change the producer's name to reflect the current iteration of an integrating resource. Make a note on any earlier name if considered important for identification or access (see 2.17.6.54.3).

Alternative

If the changes have been numerous, make a general note (see 2.17.6.54.3).

2.7.2 Place of Production

2.7.2.1 Scope

[unchanged]

2.7.2.2 Sources of Information

Take places of production from any source. the following sources (in order of preference):

- a)—the same source as the producer's name (see 2.7.4.2)
- b) another source within the resource itself (see 2.2.2)
- c) one of the other sources of information specified at 2.2.4.

2.7.2.3 Recording Place of Production

Record the place of production by applying the basic instructions at 2.7.1.

<u>Record Include both</u> the local place name (city, town, etc.). <u>Also record</u> and the name of the larger jurisdiction or jurisdictions (state, province, etc., and/or country) <u>if considered important for identification or access. present on the source of information</u>.

If the full address is stated on the resource or is readily available from another source, record it in a note if considered important for identification or access (see 2.17.6).

Optional Additions

Include the full address as part of the local place name, if considered important for identification or access.

Supply the name of the larger jurisdiction (state, province, etc., and/or country) as part of the local place name if considered important for identification or access. Indicate that the information was taken from a source outside the resource itself (see 2.2.4).

Include any preposition appearing with the place name that is required to make sense of the statement.

If the place name as transcribed <u>it appears on the resource</u> is known to be fictitious, or requires clarification, <u>record the real name and</u> make a note giving the actual <u>fictitious</u> place name, etc. <u>if</u> <u>considered important for identification or access</u> (see 2.17.6.3).

2.7.2.4 More Than One Place of Production

If <u>there is</u> more than one place of production is named on the source of information, record the <u>additional</u> place names <u>if considered important for identification or access</u>. in the order indicated by the sequence, layout, or typography of the names on the source of information.

lf:

there are two or more producers

and

there are two or more places associated with one or more of the producers then:

record the place names associated with each producer in the order indicated by the sequence, layout, or typography of the place names on the source of information.

2.7.2.5 Place of Production in More Than One Language or Script

If the place of production appears on the source of information in more than one language or script, record the form that is in the language or script of the title proper. If this criterion does not apply, record the place name in the language or script <u>preferred by the agency preparing the description that appears first</u>.

2.7.2.6 Place of Production Uncertain Not Identified in the Resource

If the place of production <u>cannot be</u> is not identified in the resource, <u>record</u> supply the place of production or probable place of production if it can be determined. Apply the instructions in this order of preference:

ba) probable place (see 2.7.2.6.12)

eb) known country, state, province, etc. (see 2.7.2.6.23)

dc) probable country, state, province, etc. (see 2.7.2.6.34)

If the place of production is known, supply the local place name (city, town, etc.). Include the name of the larger jurisdiction if necessary for identification.

If the country, state, province, etc., of production is uncertain, <u>record</u> supply the name of the probable country, state, province, etc., of production followed by a question mark.

Record *Place of production not identified* if neither a known nor a probable local place or country, state, province, etc., of production can be determined.

2.7.4 Producer's Name

2.7.4.1 Scope

2.7.4.2 Sources of Information

Take producers' names from any source. the following sources (in order of preference):

a)—the same source as the title proper (see 2.3.2.2)

- b) another source within the resource itself (see 2.2.2)
- c) one of the other sources of information specified at 2.2.4.

2.7.4.3 Recording Producers' Names

Record the producer's name by applying the basic instructions at 2.7.1.

EXAMPLE

typed by George L. Upshur

bound by Julia P. Wightman

etched by J.C. Allen

Optional Omission

Omit levels in a corporate hierarchy that are not required to identify the producer. Do not use a mark of omission (...) to indicate such an omission.

If the name as transcribed it appears on the resource is known to be fictitious, or requires clarification, record the real name and make a note giving the actual fictitious name, etc. if considered important for identification or access (see 2.17.6.3).

For instructions on recording the relationship to the producer of an unpublished resource, see **21.2**.

2.7.4.4 Statement of Function

When Record words or phrases indicating the function performed by a person, family, or corporate body as they appear on the source of information, record the function in a language and script preferred by the agency preparing the description, if considered important for identification or access.

Optional Addition

If the function of a person, family, or corporate body recorded in the producer's name subelement is not explicit or clear, add a term indicating the function. Indicate that the information was taken from a source outside the resource itself (see 2.2.4).

2.7.4.5 More Than One Producer

If more than one person, family, or corporate body is named as a producer of the resource, record the <u>additional</u> producers' names <u>if considered important for identification or access</u>. in the order indicated by the sequence, layout, or typography of the names on the source of information.

2.7.4.6 Producer's Name in More Than One Language or Script

If the name of a producer appears on the source of information in more than one language or script, record the form that is in the language or script of the title proper. If this criterion does not apply, record the name in the language or script preferred by the agency preparing the description. that appears first.

2.7.4.7 Producer's Name Uncertain No Producer Identified

If the producer's name cannot be identified, record the probable producer's name, if it can be determined. Follow it with a question mark.

Otherwise, Rrecord producer not identified if:

no producer is named within the resource itself

and

the producer cannot be identified from other sources (see 2.2.4).

Indicate that the information was taken from a source outside the resource itself (see 2.2.4).

2.7.4.8 Change in Producer's Name

Record parallel producers' names by applying the basic instructions at 2.7.1.

If there is more than one parallel producer's name, record the <u>additional</u> names <u>if considered</u> <u>important for identification or access</u> <u>in the order indicated by the sequence, layout, or typography of the names on the source or sources of information</u>.

2.7.6 Date of Production

CORE ELEMENT

Date of production is a core element for resources issued in an unpublished form. If the date of production appears on the source of information in more than one calendar, only the date in the calendar preferred by the agency preparing the description is required.

2.7.6.1 Scope

2.7.6.2 Sources of Information

2.7.6.3 Recording Date of Production

Record the date of production by applying the basic instructions at 2.7.1.

EXAMPLE

2006

Optional Addition

If the date as it appears in the resource is not of the Gregorian or Julian calendar, add the corresponding date or dates of the Gregorian or Julian calendar. Indicate that the information was taken from a source outside the resource itself (see 2.2.4).

If the date as it appears on the resource is represented in different calendars, record the <u>additional</u> dates <u>if considered important for identification or access</u> in the order indicated by the sequence, layout, or typography of the dates on the source of information.

If the date as it appears in the resource is known to be fictitious or incorrect, <u>record the actual</u> <u>date and</u> make a note giving the <u>actual fictitious</u> date <u>if considered important for identification or access</u> (see 2.17.6.3).

2.7.6.4 Chronograms

If the date of production as it appears on the source of information is in the form of a chronogram, transcribe record the chronogram as it appears.

Optional Addition

Add the date in numerals (in a script and calendar preferred by the agency preparing the description). Indicate that the information was taken from a source outside the resource itself (see 2.2.4).

Alternative

In place of the chronogram, supply the date in numerals (in a script and calendar preferred by the agency preparing the description). Indicate that the information was taken from a source outside the resource itself (see 2.2.4).

Make a note giving the chronogram if considered important for identification (see 2.17.6.3).

2.7.6.5 Multipart Monographs, Serials, and Integrating Resources

If the first issue, part, or iteration of a multipart monograph, serial, or integrating resource is <u>known</u> available, record the date of production of that issue, part, or iteration, followed by a hyphen.

EXAMPLE

1999-

If:

production of the resource has ceased or is complete

and

the first and last issues, parts, or iterations are $\underline{\text{known}}$ available then:

record the dates of production of the first and last issues, parts, or iterations, separated by a hyphen.

EXAMPLE

1982-2001

lf:

production of the resource has ceased or is complete and

the last issue, part, or iteration is $\underline{\text{known}}$ available, but not the first *then:*

record the production date of the last issue, part, or iteration, preceded by a hyphen.

EXAMPLE

-2002

For an integrating resource, supply the date of the last update, if considered important for identification.

If the date of production is the same for all issues, parts, or iterations, record only that date as the single date.

EXAMPLE

1967

If the first and/or last issue, part, or iteration is not known available, supply an approximate date or dates by applying the instructions at 1.9.2.

If the date or dates cannot be approximated for a multipart monograph, serial, or integrating resource, do not record a date of production.

2.7.6.6 Date of Production Uncertain for Not Identified in a Single-Part Resource

If the date of production <u>cannot be</u> is not identified <u>for</u> in a single-part resource, supply the date or approximate date of production. <u>Apply the guidelines at 1.9.2 but do not indicate that the date was taken from a source outside the resource itself.</u>

Otherwise, record date of production not identified.

If the date or an approximate date of production for a single part resource cannot reasonably be determined, record date of production not identified. Indicate that the information was taken from a source outside the resource itself (see 2.2.4).

Alternative

If the changes have been numerous, make a general note (see 2.17.6.5.1).

2.7.1.5.2 Serials

Make a note (see 2.17.6.5.2) if:

the place of production changes on a later issue or part of a serial

and

the change is considered important for identification or access.

If the change is only in the presentation of the place name, make a note if the change is considered important for identification.

Alternative

If the changes have been numerous, make a general note (see 2.17.6.5.2).

Make a note (see 2.17.6.5.2) if:

a producer's name changes or a different producer is named on a later issue or part of a serial

and

the change is considered important for identification or access.

If the change is only in the presentation of the name, make a note if the change is considered important for identification.

Alternative

If the changes have been numerous, make a general note (see 2.17.6.5.2).

2.7.1.5.3 Integrating Resources

Change the place of production to reflect the current iteration of an integrating resource. Make a note on the earlier place if considered important for identification or access (see 2.17.6.5.3).

Change the producer's name to reflect the current iteration of an integrating resource. Make a note on any earlier name if considered important for identification or access (see 2.17.6.5.3).

Alternative

If the changes have been numerous, make a general note (see 2.17.6.5.3).

2.7.2 Place of Production

2.7.2.1 Scope

[unchanged]

2.7.2.2 Sources of Information

Take places of production from any source.

2.7.2.3 Recording Place of Production

Record the place of production by applying the basic instructions at 2.7.1.

Record the local place name (city, town, etc.). Also record the name of the larger jurisdiction or jurisdictions (state, province, etc., and/or country) if considered important for identification or access.

If the full address is stated on the resource or is readily available from another source, record it in a note if considered important for identification or access (see 2.17.6).

Include any preposition appearing with the place name that is required to make sense of the statement.

If the place name as it appears on the resource is known to be fictitious, or requires clarification, record the real name and make a note giving the fictitious name, etc. if considered important for identification or access (see 2.17.6.3).

2.7.2.4 More Than One Place of Production

If there is more than one place of production, record the additional place names if considered important for identification or access.

If:

there are two or more producers

and

there are two or more places associated with one or more of the producers *then:*

record the place names associated with each producer.

2.7.2.5 Place of Production in More Than One Language or Script

If the place of production appears on the source of information in more than one language or script, record the form that is in the language or script of the title proper. If this criterion does not apply, record the place name in the language or script preferred by the agency preparing the description.

2.7.2.6 Place of Production Uncertain

If the place of production cannot be identified, record the probable place of production if it can be determined. Apply the instructions in this order of preference:

- a) probable place (see 2.7.2.6.1)
- b) known country, state, province, etc. (see 2.7.2.6.2)
- c) probable country, state, province, etc. (see 2.7.2.6.3)

d) unknown place (see 2.7.2.6.4).

2.7.2.6.1 Probable Place of Production

If the place of production is uncertain, record the name of the probable local place of production. Include the name of the larger jurisdiction if necessary for identification. Follow the place name with a question mark.

EXAMPLE

Port Alberni, British Columbia?

2.7.2.6.2 Known Country, State, Province, Etc., of Production

If the probable local place is unknown, but the name of the country, state, province, etc., of production is known, record the name of the country, state, province, etc.

EXAMPLE

Denmark

2.7.2.6.3 Probable Country, State, Province, Etc., of Production

If the country, state, province, etc., of production is uncertain, record the name of the probable country, state, province, etc., of production followed by a question mark.

EXAMPLE

France?

2.7.2.6.4 Unknown Place of Production

Record *Place of production not identified* if neither a known nor a probable local place or country, state, province, etc., of production can be determined.

2.7.4.1 Scope

2.7.4.2 Sources of Information

Take producers' names from any source.

2.7.4.3 Recording Producers' Names

Record the producer's name by applying the basic instructions at 2.7.1.

EXAMPLE

typed by George L. Upshur bound by Julia P. Wightman etched by J.C. Allen

Optional Omission

Omit levels in a corporate hierarchy that are not required to identify the producer.

If the name as it appears on the resource is known to be fictitious, or requires clarification, record the real name and make a note giving the fictitious name, etc. if considered important for identification or access (see 2.17.6.3).

For instructions on recording the relationship to the producer of an unpublished resource, see **21.2**.

2.7.4.4 Statement of Function

When words or phrases indicating the function performed by a person, family, or corporate body appear on the source of information, record the function in a language and script preferred by the agency preparing the description, if considered important for identification or access.

2.7.4.5 More Than One Producer

If more than one person, family, or corporate body is named as a producer of the resource, record the additional producers' names if considered important for identification or access.

2.7.4.6 Producer's Name in More Than One Language or Script

If the name of a producer appears on the source of information in more than one language or script, record the form that is in the language or script of the title proper. If this criterion does not apply, record the name in the language or script preferred by the agency preparing the description.

2.7.4.7 Producer's Name Uncertain

If the producer's name cannot be identified, record the probable producer's name, if it can be determined. Follow it with a question mark.

Otherwise, record producer not identified

2.7.4.8 Change in Producer's Name

2.7.5 Parallel Producer's Name

2.7.5.1 Scope

2.7.5.2 Sources of Information

Take parallel producers' names from any source

2.7.5.3 Recording Parallel Producers' Names

Record parallel producers' names by applying the basic instructions at 2.7.1.

If there is more than one parallel producer's name, record the additional names if considered important for identification or access.

2.7.6 Date of Production

CORE ELEMENT

Date of production is a core element for resources issued in an unpublished form. If the date of production appears on the source of information in more than one calendar, only the date in the calendar preferred by the agency preparing the description is required.

2.7.6.1 Scope

2.7.6.3 Recording Date of Production

Record the date of production by applying the basic instructions at 2.7.1.

EXAMPLE

2006

Optional Addition

If the date as it appears in the resource is not of the Gregorian or Julian calendar, add the corresponding date or dates of the Gregorian or Julian calendar.

If the date as it appears on the resource is represented in different calendars, record the additional dates if considered important for identification or access.

If the date as it appears in the resource is known to be fictitious or incorrect, record the actual date and make a note giving the fictitious date if considered important for identification or access (see 2.17.6.3).

2.7.6.4 Chronograms

If the date of production as it appears on the source of information is in the form of a chronogram, record the chronogram as it appears.

Optional Addition

Add the date in numerals (in a script and calendar preferred by the agency preparing the description).

Alternative

In place of the chronogram, supply the date in numerals (in a script and calendar preferred by the agency preparing the description).

Make a note giving the chronogram if considered important for identification (see 2.17.6.3).

2.7.6.5 Multipart Monographs, Serials, and Integrating Resources

If the first issue, part, or iteration of a multipart monograph, serial, or integrating resource is known, record the date of production of that issue, part, or iteration, followed by a hyphen.

EXAMPLE

1999-

lf:

production of the resource has ceased or is complete

and

the first and last issues, parts, or iterations are known

then:

record the dates of production of the first and last issues, parts, or iterations, separated by a hyphen.

EXAMPLE

1982-2001

lf:

production of the resource has ceased or is complete

and

the last issue, part, or iteration is known, but not the first

then:

record the production date of the last issue, part, or iteration, preceded by a hyphen.

EXAMPLE

-2002

For an integrating resource, supply the date of the last update, if considered important for identification.

If the date of production is the same for all issues, parts, or iterations, record only that date as the single date.

EXAMPLE

1967

If the first and/or last issue, part, or iteration is not known, supply an approximate date or dates by applying the instructions at 1.9.2.

If the date or dates cannot be approximated for a multipart monograph, serial, or integrating resource, do not record a date of production.

2.7.6.6 Date of Production Uncertain for a Single-Part Resource

If the date of production cannot be identified for a single-part resource, supply the date or approximate date of production. Apply the guidelines at 1.9.2 but do not indicate that the date was taken from a source outside the resource itself.

Otherwise, record date of production not identified.
