#### Abstract

This revised proposal presents 3 options for recording Plate Number for Music, based on responses from the RSC.


## Issues requiring resolution

The responses from ACOC, ALA, and LC to RSC/MusicWG/2 were, with some minor suggestions for improvement, in favor of the proposal. The response from Europe, while initially indicating agreement with the MusicWG proposal, actually preferred a different method of treating the issues raised in the Working Group proposal. The CCC response disagreed with the proposal entirely.

After a discussion of the responses, the Working Group was unable to come to a consensus for the best way forward. Therefore 3 options are provided in this revised proposal with the hope that the RSC can come to a decision.

Option 1 retains the current instruction as written, with some modifications. Paragraph 2 of 2.15.3.1 is modified slightly to include an addition made by the Working Group for a following number that corresponds to an individual page or plate. 2.15.3.3 incorporates the suggestion from ALA to replace the phrase "is preceded by" with the word "includes". This option represents the approach favored by CCC, however the scope still retains the sentence concerning following numbers. Several members of the Working Group felt that it was unhelpful to obscure the fact that such numbers do exist. In any case, whether or not a following number should be considered part of the plate number or not will be left to community decision.

Option 2 is essentially what was proposed in RSC/MusicWG/2, but also incorporates the changes suggested in the ALA response for 2.15.3.3. For the majority of Working Group members, this is still the preferred option for the reasons articulated in the original proposal.

Option 3 is the opposite of option 2 and is the approach favored in the European response. It represents the historical practice of how music catalogers have traditionally recorded plate numbers, i.e. without a following number that represents the number of pages or plates. The Alternatives in this option would be to record following numbers as part of the plate number.
