Note 1

Having rejected all the recommendations, NARDAC has made suggestions for alternative wording of each recommendation, against the outcome that a majority vote leads to the acceptance of this proposal.

Note 2

<u>Examples Editor</u> would like to "retain the original order of contents in the Toolkit for the Aggregates guidance chapter (i.e., 'Aggregating expressions' before 'Aggregating works'). This order logically follows the flow of the WEMI model."

Note 3

<u>Examples Editor</u> suggests the following amendment (mark-up reflects change from text in proposal):

"Under 'Aggregate manifestations,' add text to second paragraph:

<u>In addition to the distinct expressions that are aggregated</u>, An aggregate also embodies one and only one aggregating expression that realizes one and only one aggregating work that is the plan for selecting and arranging the expressions that are embodied in an aggregate.

This addition helps to clarify the difference between aggregates and aggregating expressions"

Note 4

<u>Examples Editor</u> suggests the addition of a diagram, "perhaps one based on the diagram illustrating the model for aggregates in the LRM".

Note 5

<u>EURIG</u> suggests, "As this change is, in large part, to support education and training, we feel that the terms would benefit from illustrative examples and diagrams which would be useful in the classroom".

Note on process from the RSC Secretary

Having discussed it with the RSC Chair, I wanted to make a comment on NARDAC's rejection of all proposals while suggesting specific wording changes in case their rejection does not carry the discussion in their favour. While not doubting that this is intended to be helpful, it conflates two stages of the discussion process and makes the presentation of what is intended as helpful information sound defensive and possibly

even adversarial. There has been an upward creep in this sort of response from RSC members – it is not solely an issue for the NARDAC representative. However, this response is, perhaps, a tipping point, and it would be worthwhile, I think, for the voting members of the RSC to discuss the procedure for what to do when they want to reject a recommendation but also want to be helpful if the recommendation is approved. If we can discuss this in the Executive Session of this RSC meeting, I can include the decision made in the Operations Documents as appropriate. The annual review of the Operations Documents is also under discussion at this meeting, so the timing of this discussion would be good.

With regard to RSC/TechnicalWG/2024/2/rev/NARDAC response, I am suggesting here that voting members take its suggestions for rewording of specific recommendations into account at the appropriate time in their discussion of RSC/TechnicalWG/2024/2/rev. The response is set out in a clear order, so you can see where each rewording is set out.
